The House met pursuant to adjournment.

The journal of the previous legislative day was read and approved.

### **INTRODUCTION OF BILLS**

The following bills were introduced:

**H. B. No. 515 -** Representatives Hoops, Riedel. Cosponsors: Representatives Stoltzfus, Stewart, Schmidt, Seitz.

To amend section 5747.01 of the Revised Code to exempt from income tax certain gains from the sale of an ownership interest in a business.

H. B. No. 516 - Representative Hoops.

To enact section 5534.836 of the Revised Code to designate U.S. Route 224 in Putnam County as the "Putnam County Veterans Memorial Highway."

H. B. No. 517 - Representative Hoops.

To enact section 5534.843 of the Revised Code to designate a portion of State Route 107 in Williams County as the "Williams County Veterans Memorial Highway."

H. B. No. 518 - Representative Hoops.

To amend sections 1901.01, 1901.02, 1901.021, 1901.03, 1901.08, 1901.311, 1901.34, and 1907.11 of the Revised Code to create the Fulton County Municipal Court in Wauseon on January 1, 2024, to establish one full-time judgeship in that court, to abolish the Fulton County Courty Court on that date, and to provide for the election for the Fulton County Municipal Court of one full-time judge in 2023.

H. B. No. 519 - Representatives Roemer, Lanese.

Cosponsors: Representatives Brinkman, Click, Johnson, Koehler, Schmidt.

To amend sections 718.05, 718.27, 718.85, and 718.89 of the Revised Code to modify the law regarding extensions for filing municipal income tax returns and to limit penalties for late filings.

H. B. No. 520 - Representative Hillyer.

Cosponsors: Representatives Seitz, Schmidt.

To amend sections 1321.632, 1321.68, and 1321.99 and to enact section 1321.691 of the Revised Code regarding precomputed consumer installment loan acceleration and conversion, interest rates, refinance charges, bona fide errors, and remote work for consumer installment lender employees.

H. B. No. 521 - Representative Hillyer.

To enact section 5534.608 of the Revised Code to designate an overpass over U.S. Route 250 in Tuscarawas County as the "Specialist Ronald Gene Johnson Memorial Overpass."

Said bills were considered the first time.
