INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 530 - Representative Lampton.

Cosponsors: Representatives Seitz, Hillyer, Carfagna, White.

To amend sections 3956.01, 3956.03, 3956.04, 3956.06, 3956.07, 3956.08, 3956.09, 3956.10, 3956.11, 3956.12, 3956.13, 3956.16, 3956.18, and 3956.20; to enact new section 3956.19; and to repeal section 3956.19 of the Revised Code to amend the law governing the Ohio Life and Health Insurance Guaranty Association.

H. B. No. 531 - Representative Ghanbari.

Cosponsor: Representative Smith, K.

To amend sections 167.05 and 309.09 of the Revised Code to allow a county prosecutor to provide legal services to a metropolitan planning organization, regional transportation planning organization, or regional council of governments.

Said bills were considered the first time.
