#### INTRODUCTION OF BILLS

The following bills were introduced:

## H. B. No. 713 - Representative Ginter.

To amend section 4513.34 of the Revised Code to require the Ohio Department of Transportation and local authorities to issue special regional heavy hauling permits within every county that borders Pennsylvania.

To amend sections 4111.14, 5122.28, and 5123.87; to enact new section

4111.06; and to repeal section 4111.06 of the Revised Code to eliminate subminimum wage for persons with physical or mental disabilities.

### H. B. No. 717 - Representative Wiggam.

To enact section 5534.902 of the Revised Code to designate a portion of State Route 226 in Wayne County as the "Wayne County Gold Star Family Memorial Highway."

### H. B. No. 718 - Representatives Davis, Crossman.

Cosponsors: Representatives Denson, Sobecki, Lepore-Hagan, Miller, A., Weinstein, Ingram, Smith, K., Miranda, Brent, Troy, Upchurch, Sweeney.

To amend section 1345.99 and to enact section 1345.033 of the Revised Code to prohibit price gouging of infant formula and to declare an emergency.
