### INTRODUCTION OF BILLS

The following bills were introduced:

**H. B. No. 735** - Representatives LaRe, Miller, K.

Cosponsors: Representatives Carruthers, Holmes, Gross, Riedel, Schmidt, Ginter, White, Plummer.

To amend sections 2919.25 and 2929.14 of the Revised Code to increase the sentencing range for third degree felony domestic violence and to create a presumption in favor of a prison term for the offense.

**H. B. No. 736** - Representative Abrams.

Cosponsors: Representatives Hoops, Holmes, Bird, Carruthers, Gross, Riedel, Koehler, Richardson, Sheehy, Schmidt.

To enact section 5534.484 of the Revised Code to designate a portion of Interstate Route 71 in Hamilton County as the "Patrolman David L. Cole Memorial Highway."

**H. B. No. 737** - Representative Powell.

To enact section 5534.918 of the Revised Code to designate a portion of State Route 571 in Darke County as the "PFC Dale Marker Memorial Highway."

**H. B. No. 738** - Representatives Leland, Hicks-Hudson.

Cosponsors: Representatives Kelly, Ingram, Addison, Smith, K., Lightbody, Humphrey, Upchurch, Davis, Miranda, Weinstein, Liston, Blackshear, Brown, Miller, J., Sobecki, Lepore-Hagan, Boggs, Sheehy, Brent, Robinson, West.

To amend sections 181.25, 2929.06, 2953.21, and 2953.23 and to enact sections 181.26 and 2953.85 of the Revised Code to make changes to the law regarding postconviction relief proceedings and to establish the Ohio Innocence Commission.

Said bills were considered the first time.
