The following bills were introduced and considered for the first time:

**S. B. No. 3** - Senator Roegner.

To enact sections 4723.11, 4723.111, 4723.112, 4723.113, 4723.114, and 4723.115 of the Revised Code to enter into the Nurse Licensure Compact.

**S. B. No. 4** - Senator Roegner.

To amend sections 149.43 and 5913.01 of the Revised Code to include emergency service telecommunicators and certain Ohio National Guard members as individuals whose residential and familial information is exempt from disclosure under the Public Records Law.

**S. B. No. 5** - Senators Roegner, Blessing.

To amend section 4755.48 and to enact sections 4755.57 and 4755.571 of the Revised Code to enter into the Physical Therapy Licensure Compact.

**S. B. No. 6** - Senators Roegner, Huffman, S.

To enact sections 4731.11, 4731.111, and 4731.112 of the Revised Code to enter into the Interstate Medical Licensure Compact.

**S. B. No. 7** - Senator Roegner.

To enact sections 4755.14 and 4755.141 of the Revised Code to enter into the Occupational Therapy Licensure Compact.
