The following bills were introduced and considered for the first time:

S. B. No. 146 - Senator Antani.

To enact section 5525.26 of the Revised Code to require the Director of Transportation to adopt rules that prevent any particular type of highway pavement from receiving priority in the highway construction bidding process.

S. B. No. 147 - Senator Hottinger.

To amend section 5739.01 of the Revised Code to exempt from sales tax memberships to gyms or other recreational facilities operated by nonprofit 501(c)(3) organizations.

To enact section 4112.33 of the Revised Code to establish the New African Immigrants Grant and Gift Fund in the state treasury.
