To enact sections 3702.3011 and 3727.25 of the Revised Code regarding surgical smoke.

S. B. No. 162 - Senator Reineke.

To amend sections 4503.10, 4503.12, 5537.04, and 5537.16 and to enact sections 5537.041 and 5537.29 of the Revised Code to expand the authority of the Ohio Turnpike and Infrastructure Commission regarding evasion of tolls on the Ohio turnpike and disclosure of personal information.

S. B. No. 163 - Senator Romanchuk.

To enact section 5534.899 of the Revised Code to designate a portion of State Route 13 in Richland County as the "PFC Steven D. Smith Memorial Highway."

S. B. No. 164 - Senators Hottinger, Yuko.
