The Senate met pursuant to adjournment.

Pursuant to Senate Rule No. 3, the Clerk called the Senate to order.

Senator Hackett was selected to preside according to the rule.

The journal of the last legislative day was read and approved.

INTRODUCTION AND FIRST CONSIDERATION OF BILLS

The following bills were introduced and considered for the first time:

S. B. No. 243 - Senator Williams.

Cosponsors: Senators Fedor, Yuko, Craig, Maharath.

To amend sections 109.73, 109.77, 109.79, 109.80, 4117.10, and 5503.05 and to enact sections 109.805, 109.806, and 2933.84 of the Revised Code to prohibit biased policing and other status-based profiling.

S. B. No. 244 - Senator Williams. Cosponsors: Senators Maharath, Thomas.

To amend, for the purpose of adopting a new section number as indicated in parentheses, section 4105.191 (4105.22), and to enact section 4105.23 of the Revised Code to amend the law regarding elevators.

S. B. No. 245 - Senator Williams.

To amend section 4732.10 of the Revised Code to modify the supervised professional experience requirement to obtain a psychologist license.

S. B. No. 246 - Senators Rulli, Lang.

Cosponsors: Senators Schaffer, Roegner, Antani.

To amend sections 5733.04, 5733.41, 5747.01, 5747.03, 5747.08, 5747.11, 5747.13, 5747.132, 5747.14, 5747.15, 5747.41, 5747.42, 5747.43, 5747.44, 5747.45, 5747.451, 5747.453, and 5747.98 and to enact sections 5747.38 and 5747.39 of the Revised Code to levy a tax on a pass-through entity's income apportioned to Ohio and to authorize a refundable income tax credit for an owner for such tax paid.

S. B. No. 247 - Senators Lang, Roegner. Cosponsors: Senators Cirino, Reineke, Romanchuk, Schaffer. To amend section 5747.01 of the Revised Code to exempt from income tax certain gains from the sale of an ownership interest in a business.

S. B. No. 248 - Senator Antani.

To amend section 3313.601 of the Revised Code to require rather than permit school districts to provide a moment of silence each school day.

S. B. No. 249 - Senator Wilson.

Cosponsors: Senators Cirino, Romanchuk.

To enact sections 1355.01, 1355.02, 1355.03, 1355.04, 1355.05, 1355.06, 1355.07, 1355.08, 1355.09, 1355.10, and 1355.11 of the Revised Code to create a regulatory sandbox program for novel financial products and services.

S. B. No. 250 - Senators Hoagland, Gavarone. Cosponsors: Senators Schaffer, Cirino, Romanchuk, Reineke, Craig, Antonio, Yuko, Wilson, Rulli, Hottinger.

To amend section 5533.04 of the Revised Code to designate the portion of U.S. 20 in Ohio as the "Ohio Medal of Honor Highway."

S. B. No. 251 - Senators Schaffer, Maharath. Cosponsors: Senators Yuko, Wilson.

To amend section 4109.07 of the Revised Code to allow a person under sixteen years of age to be employed after 7 p.m. during the school year.

S. B. No. 252 - Senator Lang.

Cosponsors: Senators Brenner, Cirino, Hackett, Hottinger, Huffman, S., Johnson, McColley, Reineke, Romanchuk, Rulli, Schaffer, Schuring, Wilson.

To enact section 2307.931 of the Revised Code to require a plaintiff in a tort action alleging an asbestos claim to file a sworn statement of specified disclosures.
