S. B. No. 260 - Senator Lang.

To amend section 9.48 of the Revised Code to expand political subdivision joint purchasing authority to expressly include purchases for construction services.

S. B. No. 261 - Senator Huffman, S.

Cosponsor: Senator Yuko.

To amend sections 109.572, 3796.01, 3796.02, 3796.03, 3796.032, 3796.05, 3796.06, 3796.061, 3796.08, 3796.10, 3796.11, 3796.12, 3796.13, 3796.14, 3796.15, 3796.16, 3796.17, 3796.18, 3796.19, 3796.20, 3796.21, 3796.22, 3796.23, 3796.27, 3796.30, 4731.30, and 4776.01; to enact sections 3796.35, 4731.303, and 4731.304; and to repeal sections 3796.031 and 3796.04 of the Revised Code to amend the law related to medical marijuana.

S. B. No. 262 - Senator Maharath.

Cosponsor: Senator Antonio.

To enact section 2307.68 of the Revised Code to permit a person to file a civil action for damages and injunctive relief against another person who causes the person to have an unintended pregnancy, regardless of the circumstances.
