S. B. No. 280 - Senator Fedor.

To amend section 3307.67 of the Revised Code regarding adjustments by the State Teachers Retirement Board to the cost-of-living adjustment.

S. B. No. 281 - Senator Schaffer.

Cosponsors: Senators Romanchuk, Cirino, Antonio.

To amend section 122.99 and to enact section 122.631 of the Revised Code to authorize reimbursements for landlords for lost revenue due to a COVID-19-related federal eviction moratorium.
