INTRODUCTION AND FIRST CONSIDERATION OF BILLS

The following bills were introduced and considered for the first time:

S. B. No. 282 - Senator O'Brien.

To enact section 5534.821 of the Revised Code to designate a bridge that is part of State Route 304 in the city of Hubbard in Trumbull County as the "Purple Heart Veterans Memorial Bridge."

S. B. No. 283 - Senator O'Brien.

To enact section 5534.513 of the Revised Code to designate a portion of State Route 84 in Ashtabula county as the "World War II Veterans Memorial Highway."

S. B. No. 284 - Senator Maharath.

Cosponsors: Senators Sykes, Fedor, Thomas, Yuko.

To amend sections 5725.98, 5726.98, 5729.98, 5747.98, and 5751.98 and to enact sections 5725.36, 5726.58, 5727.242, 5727.301, 5729.19, 5736.51, 5747.83, and 5751.55 of the Revised Code to authorize a tax credit for contributions to certain child care programs.

S. B. No. 285 - Senators Yuko, Dolan.

To amend section 4501.21 and to enact section 4503.559 of the Revised Code to create the Playhouse Square license plate.
