To enact section 5534.831 of the Revised Code to designate a portion of State Route 113 in Erie County as the "U.S. Navy Corpsman Maxton Sowiak Memorial Highway."

S. B. No. 313 - Senators Gavarone, Manning.

To amend sections 1506.01, 1506.02, 1506.06, 1506.07, 1506.08, 1506.09, 1506.11, 1506.40, 1506.41, 1506.42, and 1506.44; to enact sections 1506.401, 1506.402, 1506.403, and 1506.404; and to repeal section 1506.021 of the Revised Code to alter the law governing coastal management.
