### ONE HUNDRED NINETY-SIXTH DAY Senate Chamber, Columbus, Ohio Wednesday, November 16, 2022, 11:00 o'clock a.m.

The Senate met pursuant to adjournment.

Prayer was offered by Pastor Brian Solomon, Capitol Ministries in Columbus, Ohio, followed by the Pledge of Allegiance to the Flag.

The journal of the last legislative day was read and approved.
