**A CONCURRENT RESOLUTION**

To urge the Congress of the United States to oppose any 1  
COVID-19 vaccine mandates made by government entities 2  
and to prohibit discrimination based on COVID-19 3  
vaccination status. 4

**BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE STATE OF OHIO (THE SENATE CONCURRING):**

WHEREAS, On Thursday, September 9, 2021, President Biden 5  
released a plan to require all employers with 100 employees or 6  
more to ensure their workers are vaccinated or tested weekly; 7  
and 8

WHEREAS, President Biden's plan also requires employers to 9  
provide paid time off for employees to get vaccinated; and 10

WHEREAS, President Biden's plan also encourages states to 11  
adopt vaccine requirements for all school employees; now 12  
therefore be it 13

RESOLVED, That we, the members of the 134th General 14

Assembly of Ohio, urge the Congress of the United States to 15  
prohibit any government entity from enacting or enforcing COVID- 16  
19 immunization requirements; and be it further 17

RESOLVED, That we, the members of the 134th General 18  
Assembly of Ohio, urge the Congress of the United States to 19  
prohibit a government entity from requiring an individual to 20  
show proof of vaccination against or immunity from COVID-19 or 21  
provide the individual's COVID-19 vaccination or immunity 22  
status; and be it further 23

RESOLVED, That we, the members of the 134th General 24  
Assembly of Ohio, urge the Congress of the United States to 25  
prohibit a government entity from discriminating in favor of or 26  
against an individual based on COVID-19 immunization status, 27  
including but not limited to denying an individual the full and 28  
equal enjoyment of goods, services, privileges, advantages, 29  
facilities, and public spaces based on the individual's COVID-19 30  
vaccination or immunity status; and be it further 31

RESOLVED, That we, the members of the 134th General 32  
Assembly of Ohio, find President Biden's plan, to assess fines 33  
to large employers that do not require their employees to be 34  
vaccinated or submit to weekly COVID-19 testing, to be an 35  
unconstitutional overreach of executive authority as provided in 36  
Article II of the United States Constitution; and be it further 37

RESOLVED, That the Clerk of the Ohio House of 38  
Representatives transmit duly authenticated copies of this 39  
resolution to all members of the Ohio Congressional delegation, 40  
the Clerk of the United States House of Representatives, the 41  
Secretary of the United States Senate, and the news media of 42  
Ohio. 43
