A RESOLUTION

Honoring Ohio Task Force One on its service to the Surfside, Florida, community after the collapse of Champlain Tower.

WHEREAS, The members of the Senate of the 134th General Assembly of Ohio are pleased to pay tribute to Ohio Task Force One on its rescue efforts in the aftermath of the tragic collapse of Champlain Tower in Surfside, Florida; and

WHEREAS, Ohio Task Force One is deserving of high praise, for it has certainly proven to be an important asset to the State of Ohio. One of the twenty-eight Urban Search and Rescue teams that function within the National US&R Response System managed by the Federal Emergency Management Association, Ohio Task Force One exists under the joint oversight of the Miami Valley Fire EMS Alliance, a council of governments in Greater Dayton and Ohio, and the Ohio Emergency Management Agency. In addition, it is comprised of team members who come from both the private and public sectors, including fire and law enforcement personnel, medical and hospital professionals, engineers, and a large volunteer base; and

WHEREAS, On June 24, 2021, Champlain Tower, a 12-story condominium 16 in Surfside, Florida, partially collapsed. Rescue efforts persisted for nearly three weeks following the incident, after which there was a transition from rescue to recovery until July 23, 2021. Though many building residents were rescued on the day of the collapse and in the ensuing response efforts, a total of ninety-eight people lost their lives as a result of this tragedy. Ohio Task Force One deployed eighty-one members to work on the site, where they lent 240 hours of service that yielded to the bodily recovery of fourteen victims and assisted other teams in further initiatives until their return to Ohio
