BE IT RESOLVED BY THE SENATE OF THE STATE OF OHIO:		
WHEREAS, A strong, secure border benefits the United	3	
States; and	4	
WHEREAS, The well-being and safety of the citizens of the	5	
United States is being jeopardized by threats from transnational	6	
criminal organizations; and	7	
WHEREAS, It is integral to the security, well-being, and	8	
harmony of the people of the United States to sustain secure	9	
borders; and	10	
WHEREAS, The dedicated individuals of the United States	11	
Customs and Border Protection work diligently and honorably to	12	
secure borders in the most efficient and humane manner; and	13	
WHEREAS, The Governor of Ohio has allocated our state's	14	
resources to secure our borders through the assignment of over	15	
one hundred members of the Ohio National Guard to support United	16	
States Customs and Border Protection and the assignment of	17	
troopers from the Ohio State Highway Patrol to travel to Texas	18

to support local law enforcement with border surveillance; and	19
WHEREAS, Ill-motivated individuals continuously seek to	20
cause harm, danger, injury, hazard, and peril to those who	21
protect the United States' borders; and	22
WHEREAS, Those individuals who cross the United States'	23
borders without regard for the legal immigration process	24
circumvent the individuals who show respect for the rule of law;	25
and	26
WHEREAS, Those same individuals defy the right of the	27
United States to control its own sovereign territory and	28
regulate the happenings within its rightful borders; and	29
WHEREAS, The smuggling of contraband, such as drugs and	30
weapons, have plagued the United States' borders; and	31
WHEREAS, In fiscal year 2021, United States Customs and	32
Border Protection seized more than 319,000 pounds of marijuana,	33
109,000 pounds of methamphetamine, 97,000 pounds of cocaine,	34
11,000 pounds of fentanyl, and 5,400 pounds of heroin; and	35
WHEREAS, These illegal drugs are sold, spread, and used	36
throughout the American citizenry as drug overdoses and abuse	37
rates reach the highest levels on record in the United States,	38
including Ohio hitting a record death rate from opioid overdose	39
during the second quarter of 2020; and	40
WHEREAS, In 2020, 81% of overdose deaths in Ohio involved	41
illicit fentanyl or fentanyl analogs, while drug deaths related	42
to fentanyl increased 32% from 2019; and	43
WHEREAS, Most fentanyl and fentanyl-related substances	44
abused in the United States are trafficked into the country via	45
international mail, express consignment, or across the	46
southwestern border; and	47
WHEREAS, The act of human smuggling, which deliberately	48

evades immigration laws, is a daily occurrence at the	49
southwestern border according to U.S. Immigration and Customs	50
Enforcement; and	51
WHEREAS, Individuals who are smuggled into the United	52
States may be involved in transnational criminal organization	53
operations or may be forced into human trafficking situations;	54
and	55
WHEREAS, Human trafficking is a serious issue in Ohio, as	56
state sources identified over 1,300 cases between 2014 and 2020,	57
ranking the state among the ten worst in the nation for human	58
trafficking; and	59
WHEREAS, The United States Department of State has urged	60
state and local governments, as well as nonprofit organizations,	61
to address cross-border trafficking issues and support strong	62
collaboration at the borders to identify and prevent human	63
trafficking; now therefore be it	64
RESOLVED, That we, the members of the Senate of the 134th	65
General Assembly of the State of Ohio, support the investment of	66
necessary resources by the United States government to ensure	67
secure, strong, and sustainable borders; and be it further	68
RESOLVED, That the Clerk of the Senate transmit duly	69
authenticated copies of this resolution to the President Pro	70
Tempore and Secretary of the United States Senate, the Speaker	71
and Clerk of the United States House of Representatives, the	72
President and Vice President of the United States, the members	73
of the Ohio Congressional delegation, and the news media of	74
