## A RESOLUTION

Honoring Jefferson Depot, Inc. on the One Hundred Fiftieth Anniversary of the Jefferson Train Depot.

In 1872, 11 America was booming with industry, agriculture, and trade, and 12 Ashtabula and Conneaut were two of the busiest ports in the country. 13 As such, the Jefferson Train Depot became an important station on a 14 major rail corridor that provided freight and passenger services, and 15 the celebration of the One Hundred Fiftieth Anniversary of its 16 construction is a memorable observance; and 17
