BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That section 3501.022 of the Revised Code be	5

Section 2. That existing section 3501.022 of the Revised	34	
Code is hereby repealed.	35	
Section 3. All items in this act are hereby appropriated	36	
as designated out of any moneys in the state treasury to the	37	
credit of the designated fund. For all operating appropriations	38	
made in this act, those in the first column are for fiscal year	39	
2022 and those in the second column are for fiscal year 2023.	40	
The operating appropriations made in this act are in addition to	41	
any other operating appropriations made for these fiscal years.	42

The foregoing appropriation item 050620, BOE Reimbursement 46 and Education, shall be used to provide financial assistance to 47 boards of elections to conduct a special election on August 8, 48 2023, in accordance with section 3501.022 of the Revised Code, 49 as amended by this act. An amount equal to the unexpended, 50 unencumbered portion of the foregoing appropriation item 050620, 51 BOE Reimbursement and Education, at the end of fiscal year 2023 52 is hereby reappropriated to the Secretary of State for the same 53 purpose in fiscal year 2024. 54

On the effective date of this section, or as soon as 55 possible thereafter, the Director of Budget and Management shall 56 transfer \$20,000,000 cash from the General Revenue Fund to the 57 BOE Reimbursement and Education Fund (Fund 5FG0). 58

On December 31, 2023, or as soon as possible thereafter, 59 the Director of Budget and Management shall transfer cash in an 60 amount equal to the unexpended, unencumbered portion of the 61 foregoing appropriation item 050620, BOE Reimbursement and 62 Education, as of December 31, 2023, from the BOE Reimbursement 63 and Education Fund (Fund 5FG0) to the General Revenue Fund. 64

Section 5. Within the limits set forth in this act, the 65

Director of Budget and Management shall establish accounts	66
indicating the source and amount of funds for each appropriation	67
made in this act, and shall determine the manner in which	68
appropriation accounts shall be maintained. Expenditures from	69
operating appropriations contained in this act shall be	70
accounted for as though made in, and are subject to all	71
applicable provisions of, H.B. 110 of the 134th General	72
Assembly.	73
