BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. (A) The Director of Agriculture, in	4	
consultation with the Department of Public Safety, shall conduct	5	
a study regarding the sale and use of hemp products that could	6	
be used for intoxicating purposes. Not later than thirty days	7	
after the effective date of this section, the Director shall	8	
issue a report to the General Assembly, in accordance with	9	
division (B) of section 101.68 of the Revised Code, and include	10	
in the report recommendations concerning the following:	11	
(1) A definition of adult-use hemp products that captures	12	
all possible forms of hemp and hemp products that can be used	13	
for intoxicating purposes. The definition may include	14	
restrictions on the amount of tetrahydrocannabinol (THC)	15	
permitted in adult-use hemp products. The recommended	16	
restrictions shall be based on serving size and THC content per	17	
package of hemp product.

including any restrictions or requirements on how or where the	20

section, the Director may adopt rules in accordance with Chapter		
119. of the Revised Code implementing the recommendations made	41	
under that division. If rules are adopted, the rules shall be	42	
effective for one year after the issuance of the	43	
recommendations. Thereafter, the rules shall not be operative.	44
