A BILL

To amend section 4501.21 and to enact section 1
4503.542 of the Revised Code to create the "Ohio 2
Craft Brewers" license plate. 3

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That section 4501.21 be amended and section 4
4503.542 of the Revised Code be enacted to read as follows: 5

Sec. 4501.21. (A) There is hereby created in the state 6
treasury the license plate contribution fund. The fund shall 7
consist of all contributions for specialty license plates paid 8
by motor vehicle registrants and collected by the registrar of 9
motor vehicles pursuant to the Revised Code sections referenced 10
in division (B) of this section. 11

(B) The registrar shall pay the contributions the 12
registrar collects in the fund as follows: 13

The registrar shall pay the contributions received 14
pursuant to section 4503.491 of the Revised Code to the breast 15
cancer fund of Ohio, which shall use that money only to pay for 16
programs that provide assistance and education to Ohio breast 17
cancer patients and that improve access for such patients to 18
quality health care and clinical trials and shall not use any of 19

the money for abortion information, counseling, services, or 20
other abortion-related activities. 21

The registrar shall pay the contributions the registrar 22
receives pursuant to section 4503.492 of the Revised Code to the 23
organization cancer support community central Ohio, which shall 24
deposit the money into the Sheryl L. Kraner Fund of that 25
organization. Cancer support community central Ohio shall expend 26
the money it receives pursuant to this division only in the same 27
manner and for the same purposes as that organization expends 28
other money in that fund. 29

The registrar shall pay the contributions received 30
pursuant to section 4503.493 of the Revised Code to the autism 31
society of Ohio, which shall use the contributions for programs 32
and autism awareness efforts throughout the state. 33

The registrar shall pay the contributions the registrar 34
receives pursuant to section 4503.494 of the Revised Code to the 35
national multiple sclerosis society for distribution in equal 36
amounts to the northwestern Ohio, Ohio buckeye, and Ohio valley 37
chapters of the national multiple sclerosis society. These 38
chapters shall use the money they receive under this section to 39
assist in paying the expenses they incur in providing services 40
directly to their clients. 41

The registrar shall pay the contributions the registrar 42
receives pursuant to section 4503.495 of the Revised Code to the 43
national pancreatic cancer foundation, which shall use the money 44
it receives under this section to assist those who have 45
pancreatic cancer and their families. 46

The registrar shall pay the contributions the registrar 47
receives pursuant to section 4503.496 of the Revised Code to the 48

Ohio sickle cell and health association, which shall use the 49
contributions to help support educational, clinical, and social 50
support services for adults who have sickle cell disease. 51

The registrar shall pay the contributions the registrar 52
receives pursuant to section 4503.497 of the Revised Code to the 53
St. Baldrick's foundation, which shall use the contributions for 54
its research and other programs. 55

The registrar shall pay the contributions the registrar 56
receives pursuant to section 4503.498 of the Revised Code to 57
special olympics Ohio, inc., which shall use the contributions 58
for its programs, charitable efforts, and other activities. 59

The registrar shall pay the contributions the registrar 60
receives pursuant to section 4503.499 of the Revised Code to the 61
children's glioma cancer foundation, which shall use the 62
contributions for its research and other programs. 63

The registrar shall pay the contributions the registrar 64
receives pursuant to section 4503.4910 of the Revised Code to 65
the KylerStrong foundation, which shall use the contributions to 66
raise awareness of brain cancer caused by diffuse intrinsic 67
pontine glioma and to fund research for the cure of such cancer. 68

The registrar shall pay the contributions the registrar 69
receives pursuant to section 4503.4911 of the Revised Code to 70
the research institution for childhood cancer at nationwide 71
children's hospital, which shall use the contributions to fund 72
research for the cure of childhood cancers. 73

The registrar shall pay the contributions the registrar 74
receives pursuant to section 4503.50 of the Revised Code to the 75
future farmers of America foundation, which shall deposit the 76
contributions into its general account to be used for 77

educational and scholarship purposes of the future farmers of 78
America foundation. 79

The registrar shall pay the contributions the registrar 80
receives pursuant to section 4503.501 of the Revised Code to the 81
4-H youth development program of the Ohio state university 82
extension program, which shall use those contributions to pay 83
the expenses it incurs in conducting its educational activities. 84

The registrar shall pay the contributions received 85
pursuant to section 4503.502 of the Revised Code to the Ohio 86
cattlemen's foundation, which shall use those contributions for 87
scholarships and other educational activities. 88

The registrar shall pay the contributions received 89
pursuant to section 4503.505 of the Revised Code to the 90
organization Ohio region phi theta kappa, which shall use those 91
contributions for scholarships for students who are members of 92
that organization. 93

The registrar shall pay the contributions the registrar 94
receives pursuant to section 4503.506 of the Revised Code to 95
Ohio demolay, which shall use the contributions for 96
scholarships, educational programs, and any other programs or 97
events the organization holds or sponsors in this state. 98

The registrar shall pay the contributions received 99
pursuant to section 4503.507 of the Revised Code to the Ohio 100
aerospace institute, which shall use those contributions to 101
facilitate student internships in aerospace and educational 102
programming. 103

The registrar shall pay the contributions received 104
pursuant to section 4503.508 of the Revised Code to the 105
organization bottoms up diaper drive to provide funding for that 106

organization for collecting and delivering diapers to parents in need. 107

The registrar shall pay the contributions the registrar receives pursuant to section 4503.509 of the Revised Code to a kid again, incorporated for distribution in equal amounts to the Ohio chapters of a kid again. 109

The registrar shall pay each contribution the registrar receives pursuant to section 4503.51 of the Revised Code to the university or college whose name or marking or design appears on collegiate license plates that are issued to a person under that section. A university or college that receives contributions from the fund shall deposit the contributions into its general scholarship fund. 113

The registrar shall pay the contributions the registrar receives pursuant to section 4503.514 of the Revised Code to the university of Notre Dame in South Bend, Indiana, for purposes of awarding grants or scholarships to residents of Ohio who attend the university. The university shall not use any of the funds it receives for purposes of administering the scholarship program. The registrar shall enter into appropriate agreements with the university of Notre Dame to effectuate the distribution of such funds as provided in this section. 120

The registrar shall pay the contributions the registrar receives pursuant to section 4503.516 of the Revised Code to Marshall university in Huntington, West Virginia, for purposes of awarding grants or scholarships to residents of Ohio who attend the university. The university shall not use any of the funds it receives for purposes of administering the scholarship program. The registrar shall enter into appropriate agreements with Marshall university to effectuate the distribution of such 129

funds as provided in this section. 137

The registrar shall pay the contributions the registrar 138
receives pursuant to section 4503.517 of the Revised Code to the 139
university of Alabama in Tuscaloosa, Alabama, for purposes of 140
awarding grants or scholarships to residents of Ohio who attend 141
the university. The university shall not use any of the funds it 142
receives for purposes of administering the scholarship program. 143
The registrar shall enter into appropriate agreements with the 144
university of Alabama to effectuate the distribution of such 145
funds as provided in this section. 146

The registrar shall pay the contributions the registrar 147
receives pursuant to section 4503.518 of the Revised Code to the 148
Nationwide children's hospital, which shall use the 149
contributions for the "On Our Sleeves" campaign. 150

The registrar shall pay the contributions the registrar 151
receives pursuant to section 4503.519 of the Revised Code 152
equally to NAMI Ohio (national alliance on mental illness of 153
Ohio), Ohio peer recovery organizations, and OCAAR (Ohio citizen 154
advocates for addiction recovery). 155

The registrar shall pay the contributions the registrar 156
receives pursuant to section 4503.521 of the Revised Code to the 157
Ohio bicycle federation to assist that organization in paying 158
for the educational programs it sponsors in support of Ohio 159
cyclists of all ages. 160

The registrar shall pay the contributions the registrar 161
receives pursuant to section 4503.522 of the Revised Code to the 162
"friends of Perry's victory and international peace memorial, 163
incorporated," a nonprofit corporation organized under the laws 164
of this state, to assist that organization in paying the 165

expenses it incurs in sponsoring or holding charitable, 166
educational, and cultural events at the monument. 167

The registrar shall pay the contributions the registrar 168
receives pursuant to section 4503.523 of the Revised Code to the 169
fairport lights foundation, which shall use the money to pay for 170
the restoration, maintenance, and preservation of the 171
lighthouses of fairport harbor. 172

The registrar shall pay the contributions the registrar 173
receives pursuant to section 4503.524 of the Revised Code to the 174
Massillon tiger football booster club, which shall use the 175
contributions only to promote and support the football team of 176
Washington high school of the Massillon city school district. 177

The registrar shall pay the contributions the registrar 178
receives pursuant to section 4503.525 of the Revised Code to the 179
United States power squadron district seven which shall annually 180
distribute the contributions in equal amounts to all United 181
States power squadrons located in the state. Each power squadron 182
district shall use the money it receives under this section to 183
pay for the educational boating programs each district holds or 184
sponsors within this state. 185

The registrar shall pay the contributions the registrar 186
receives pursuant to section 4503.526 of the Revised Code to the 187
Ohio district Kiwanis foundation of the Ohio district of Kiwanis 188
international, which shall use the money it receives under this 189
section to pay the costs of its educational and humanitarian 190
activities. 191

The registrar shall pay the contributions the registrar 192
receives pursuant to section 4503.528 of the Revised Code to the 193
Ohio children's alliance, which shall use the money it receives 194

under this section to pay the expenses it incurs in advancing 195
its mission of sustainably improving the provision of services 196
to children, young adults, and families in this state. 197

The registrar shall pay the contributions the registrar 198
receives pursuant to section 4503.529 of the Revised Code to the 199
Ohio nurses foundation. The foundation shall use the money it 200
receives under this section to provide educational scholarships 201
to assist individuals who aspire to join the nursing profession, 202
to assist nurses in the nursing profession who seek to advance 203
their education, and to support persons conducting nursing 204
research concerning the evidence-based practice of nursing and 205
the improvement of patient outcomes. 206

The registrar shall pay the contributions the registrar 207
receives pursuant to section 4503.531 of the Revised Code to the 208
thank you foundation, incorporated, a nonprofit corporation 209
organized under the laws of this state, to assist that 210
organization in paying for the charitable activities and 211
programs it sponsors in support of United States military 212
personnel, veterans, and their families. 213

The registrar shall pay the contributions the registrar 214
receives pursuant to section 4503.532 of the Revised Code to the 215
Ohio history connection, which shall use the contributions for 216
the benefit of the Paul Laurence Dunbar house. 217

The registrar shall pay the contributions the registrar 218
receives pursuant to section 4503.533 of the Revised Code to the 219
nonprofit organization Ohio conference of teamsters and industry 220
health and welfare fund, which shall use the contributions to 221
further the nonprofit's mission. 222

The registrar shall pay the contributions the registrar 223

receives pursuant to section 4503.534 of the Revised Code to the 224
disabled American veterans department of Ohio, to be used for 225
programs that serve disabled American veterans and their 226
families. 227

The registrar shall pay the contributions the registrar 228
receives pursuant to section 4503.55 of the Revised Code to the 229
pro football hall of fame, which shall deposit the contributions 230
into a special bank account that it establishes and which shall 231
be separate and distinct from any other account the pro football 232
hall of fame maintains, to be used exclusively for the purpose 233
of promoting the pro football hall of fame as a travel 234
destination. 235

The registrar shall pay the contributions the registrar 236
receives pursuant to section 4503.542 of the Revised Code to the 237
Ohio craft brewers association. 238

The registrar shall pay the contributions that are paid to 239
the registrar pursuant to section 4503.545 of the Revised Code 240
to the national rifle association foundation, which shall use 241
the money to pay the costs of the educational activities and 242
programs the foundation holds or sponsors in this state. 243

The registrar shall pay to the Ohio pet fund the 244
contributions the registrar receives pursuant to section 245
4503.551 of the Revised Code and any other money from any other 246
source, including donations, gifts, and grants, that is 247
designated by the source to be paid to the Ohio pet fund. The 248
Ohio pet fund shall use the moneys it receives under this 249
section to support programs for the sterilization of dogs and 250
cats and for educational programs concerning the proper 251
veterinary care of those animals, and for expenses of the Ohio 252
pet fund that are reasonably necessary for it to obtain and 253

maintain its tax-exempt status and to perform its duties. 254

The registrar shall pay the contributions the registrar 255
receives pursuant to section 4503.552 of the Revised Code to the 256
rock and roll hall of fame and museum, incorporated. 257

The registrar shall pay the contributions the registrar 258
receives pursuant to section 4503.553 of the Revised Code to the 259
Ohio coalition for animals, incorporated, a nonprofit 260
corporation. Except as provided in division (B) of this section, 261
the coalition shall distribute the money to its members, and the 262
members shall use the money only to pay for educational, 263
charitable, and other programs of each coalition member that 264
provide care for unwanted, abused, and neglected horses. The 265
Ohio coalition for animals may use a portion of the money to pay 266
for reasonable marketing costs incurred in the design and 267
promotion of the license plate and for administrative costs 268
incurred in the disbursement and management of funds received 269
under this section. 270

The registrar shall pay the contributions the registrar 271
receives pursuant to section 4503.554 of the Revised Code to the 272
Ohio state council of the knights of Columbus, which shall use 273
the contributions to pay for its charitable activities and 274
programs. 275

The registrar shall pay the contributions the registrar 276
receives pursuant to section 4503.555 of the Revised Code to the 277
western reserve historical society, which shall use the 278
contributions to fund the Crawford auto aviation museum. 279

The registrar shall pay the contributions the registrar 280
receives pursuant to section 4503.556 of the Revised Code to the 281
Erica J. Holloman foundation, inc., for the awareness of triple 282

negative breast cancer. The foundation shall use the 283
contributions for charitable and educational purposes. 284

The registrar shall pay each contribution the registrar 285
receives pursuant to section 4503.557 of the Revised Code to the 286
central Ohio chapter of the Ronald McDonald house charities, 287
which shall distribute the contribution to the chapter of the 288
Ronald McDonald house charities in whose geographic territory 289
the person who paid the contribution resides. 290

The registrar shall pay the contributions the registrar 291
receives pursuant to section 4503.559 of the Revised Code to 292
playhouse square, located in Cleveland, Ohio, which shall use 293
the contributions to further its mission of presenting and 294
producing a wide variety of quality performing arts, advancing 295
arts education, and creating a superior destination for 296
entertainment, business, and residential living. 297

The registrar shall pay the contributions the registrar 298
receives pursuant to section 4503.561 of the Revised Code to the 299
state of Ohio chapter of ducks unlimited, inc., which shall 300
deposit the contributions into a special bank account that it 301
establishes. The special bank account shall be separate and 302
distinct from any other account the state of Ohio chapter of 303
ducks unlimited, inc., maintains and shall be used exclusively 304
for the purpose of protecting, enhancing, restoring, and 305
managing wetlands and conserving wildlife habitat. The state of 306
Ohio chapter of ducks unlimited, inc., annually shall notify the 307
registrar in writing of the name, address, and account to which 308
such payments are to be made. 309

The registrar shall pay the contributions the registrar 310
receives pursuant to section 4503.562 of the Revised Code to the 311
Mahoning river consortium, which shall use the money to pay the 312

expenses it incurs in restoring and maintaining the Mahoning 313
river watershed. 314

The registrar shall pay the contributions the registrar 315
receives pursuant to section 4503.564 of the Revised Code to the 316
Glen Helen association to pay expenses related to the Glen Helen 317
nature preserve. 318

The registrar shall pay the contributions the registrar 319
receives pursuant to section 4503.565 of the Revised Code to the 320
conservancy for Cuyahoga valley national park, which shall use 321
the money in support of the park. 322

The registrar shall pay the contributions the registrar 323
receives pursuant to section 4503.566 of the Revised Code to the 324
Ottawa national wildlife refuge, which shall use the 325
contributions for wildlife preservation purposes. 326

The registrar shall pay the contributions the registrar 327
receives pursuant to section 4503.567 of the Revised Code to the 328
girls on the run of Franklin county, inc., which shall use the 329
contributions to support the activities of the organization. 330

The registrar shall pay the contributions the registrar 331
receives pursuant to section 4503.569 of the Revised Code to the 332
Ohio bird sanctuary, located in Mansfield, Ohio, which shall use 333
the contributions for purposes of its operations, bird care and 334
rehabilitation, and educational programs. 335

The registrar shall pay the contributions the registrar 336
receives pursuant to section 4503.576 of the Revised Code to the 337
Ohio state beekeepers association, which shall use those 338
contributions to promote beekeeping, provide educational 339
information about beekeeping, and to support other state and 340
local beekeeping programs. 341

The registrar shall pay the contributions the registrar 342
receives pursuant to section 4503.577 of the Revised Code to the 343
national aviation hall of fame, which shall use the 344
contributions to fulfill its mission of honoring aerospace 345
legends to inspire future leaders. 346

The registrar shall pay the contributions the registrar 347
receives pursuant to section 4503.578 of the Revised Code to 348
keep Ohio beautiful, incorporated, which shall use the 349
contributions towards its mission of empowering Ohio communities 350
to take greater responsibility for improving the local 351
environment through litter prevention, beautification, community 352
greening, waste reduction, and recycling. 353

The registrar shall pay the contributions the registrar 354
receives pursuant to section 4503.579 of the Revised Code to the 355
national council of negro women, incorporated, which shall use 356
the contributions for educational purposes. 357

The registrar shall pay the contributions the registrar 358
receives pursuant to section 4503.581 of the Revised Code to the 359
Ohio past detachment commander's club, inc., which shall use the 360
contributions to support the activities of the organization. 361

The registrar shall pay the contributions the registrar 362
receives pursuant to section 4503.582 of the Revised Code to the 363
progressive animal welfare society adoption center, inc., which 364
shall use the contributions to support the activities of the 365
center. 366

The registrar shall pay the contributions the registrar 367
receives pursuant to section 4503.583 of the Revised Code to the 368
American legion, department of Ohio, inc., which shall use the 369
contributions to support the activities of the organization. 370

The registrar shall pay the contributions the registrar receives pursuant to section 4503.584 of the Revised Code to the Ohio natural energy institute to fund scholarships for students pursuing careers in the oil and natural gas industry.

The registrar shall pay to a sports commission created pursuant to section 4503.591 of the Revised Code each contribution the registrar receives under that section that an applicant pays to obtain license plates that bear the logo of a professional sports team located in the county of that sports commission and that is participating in the license plate program pursuant to division (E) of that section, irrespective of the county of residence of an applicant.

The registrar shall pay to a community charity each contribution the registrar receives under section 4503.591 of the Revised Code that an applicant pays to obtain license plates that bear the logo of a professional sports team that is participating in the license plate program pursuant to division (G) of that section.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.592 of the Revised Code to pollinator partnership's monarch wings across Ohio program, which shall use the contributions for the protection and preservation of the monarch butterfly and pollinator corridor in Ohio and for educational programs.

The registrar shall pay the contributions the registrar receives pursuant to section 4503.594 of the Revised Code to pelotonia, which shall use the contributions for the purpose of supporting cancer research.

The registrar shall pay the contributions the registrar

receives pursuant to section 4503.595 of the Revised Code to the 400
Stan Hywet hall and gardens. 401

The registrar shall pay the contributions the registrar 402
receives pursuant to section 4503.596 of the Revised Code to the 403
Cuyahoga valley scenic railroad. 404

The registrar shall pay the contributions the registrar 405
receives pursuant to section 4503.597 of the Revised Code to the 406
Circleville pumpkin show, incorporated, which shall use the 407
contributions to promote good will surrounding the Circleville 408
pumpkin show as a nonprofit annual event. 409

The registrar shall pay the contributions the registrar 410
receives pursuant to section 4503.67 of the Revised Code to the 411
Dan Beard council of the boy scouts of America. The council 412
shall distribute all contributions in an equitable manner 413
throughout the state to regional councils of the boy scouts. 414

The registrar shall pay the contributions the registrar 415
receives pursuant to section 4503.68 of the Revised Code to the 416
girl scouts of Ohio's heartland. The girl scouts of Ohio's 417
heartland shall distribute all contributions in an equitable 418
manner throughout the state to regional councils of the girl 419
scouts. 420

The registrar shall pay the contributions the registrar 421
receives pursuant to section 4503.69 of the Revised Code to the 422
Dan Beard council of the boy scouts of America. The council 423
shall distribute all contributions in an equitable manner 424
throughout the state to regional councils of the boy scouts. 425

The registrar shall pay the contributions the registrar 426
receives pursuant to section 4503.70 of the Revised Code to the 427
charitable foundation of the grand lodge of Ohio, f. & a. m., 428

which shall use the contributions for scholarship purposes. 429

The registrar shall pay the contributions the registrar 430
receives pursuant to section 4503.701 of the Revised Code to the 431
Prince Hall grand lodge of free and accepted masons of Ohio, 432
which shall use the contributions for scholarship purposes. 433

The registrar shall pay the contributions the registrar 434
receives pursuant to section 4503.702 of the Revised Code to the 435
Ohio Association of the Improved Benevolent and Protective Order 436
of the Elks of the World, which shall use the funds for 437
charitable purposes. 438

The registrar shall pay the contributions the registrar 439
receives pursuant to section 4503.703 of the Revised Code to the 440
Ohio state moose association. 441

The registrar shall pay the contributions the registrar 442
receives pursuant to section 4503.704 of the Revised Code to the 443
Antioch shrine foundation located in the municipal corporation 444
of Dayton. 445

The registrar shall pay the contributions the registrar 446
receives pursuant to section 4503.71 of the Revised Code to the 447
fraternal order of police of Ohio, incorporated, which shall 448
deposit the fees into its general account to be used for 449
purposes of the fraternal order of police of Ohio, incorporated. 450

The registrar shall pay the contributions the registrar 451
receives pursuant to section 4503.711 of the Revised Code to the 452
fraternal order of police of Ohio, incorporated, which shall 453
deposit the contributions into an account that it creates to be 454
used for the purpose of advancing and protecting the law 455
enforcement profession, promoting improved law enforcement 456
methods, and teaching respect for law and order. 457

The registrar shall pay the contributions received 458
pursuant to section 4503.712 of the Revised Code to Ohio 459
concerns of police survivors, which shall use those 460
contributions to provide whatever assistance may be appropriate 461
to the families of Ohio law enforcement officers who are killed 462
in the line of duty. 463

The registrar shall pay the contributions received 464
pursuant to section 4503.713 of the Revised Code to the greater 465
Cleveland peace officers memorial society, which shall use those 466
contributions to honor law enforcement officers who have died in 467
the line of duty and support its charitable purposes. 468

The registrar shall pay the contributions received 469
pursuant to section 4503.714 of the Revised Code to the Ohio 470
association of chiefs of police. 471

The registrar shall pay the contributions the registrar 472
receives, or has received, pursuant to section 4503.715 of the 473
Revised Code to the community foundation of Ohio's electric 474
cooperatives, which shall use the contributions to recognize and 475
memorialize fallen or injured lineworkers and support their 476
families. 477

The registrar shall pay the contributions the registrar 478
receives pursuant to section 4503.716 of the Revised Code to the 479
fallen timbers battlefield preservation commission, which shall 480
use the contributions to further the mission of the commission. 481

The registrar shall pay the contributions the registrar 482
receives pursuant to section 4503.72 of the Revised Code to the 483
organization known on March 31, 2003, as the Ohio CASA/GAL 484
association, a private, nonprofit corporation organized under 485
Chapter 1702. of the Revised Code. The Ohio CASA/GAL association 486

shall use these contributions to pay the expenses it incurs in 487
administering a program to secure the proper representation in 488
the courts of this state of abused, neglected, and dependent 489
children, and for the training and supervision of persons 490
participating in that program. 491

The registrar shall pay the contributions the registrar 492
receives pursuant to section 4503.722 of the Revised Code to the 493
Down Syndrome Association of Central Ohio, which shall use the 494
contributions for advocacy purposes throughout the state. 495

The registrar shall pay the contributions the registrar 496
receives pursuant to section 4503.724 of the Revised Code to the 497
Ohio Chapter of the American Foundation for Suicide Prevention, 498
which shall use the contributions for programs, education, and 499
advocacy purposes throughout the state. 500

The registrar shall pay the contributions the registrar 501
receives, or has received, pursuant to section 4503.725 of the 502
Revised Code to the ALS united Ohio, incorporated, which shall 503
split the contributions between that organization and the ALS 504
association northern Ohio chapter in accordance with any 505
agreement between the two organizations. The contributions shall 506
be used to discover treatments and a cure for ALS, and to serve, 507

The registrar shall pay the contributions the registrar 1138
receives pursuant to section 4503.958 of the Revised Code to 1139
Elder high school located in the municipal corporation of 1140
Cincinnati. The school shall use fifty per cent of the 1141
contributions it receives to provide tuition assistance to its 1142
students, twenty-five per cent of the contributions to benefit 1143
arts and enrichment at the school, and twenty-five per cent of 1144
the contributions to benefit athletics at the school. 1145

The registrar shall pay the contributions the registrar 1146
receives pursuant to section 4503.961 of the Revised Code to 1147
Fairfield senior high school located in the municipal 1148
corporation of Fairfield. The high school shall not use the 1149

contributions for any political purpose. 1150

The registrar shall pay the contributions the registrar 1151
receives pursuant to section 4503.962 of the Revised Code to 1152
Hamilton high school located in the municipal corporation of 1153
Hamilton. The high school shall not use the contributions for 1154
any political purpose. 1155

The registrar shall pay the contributions the registrar 1156
receives pursuant to section 4503.963 of the Revised Code to 1157
Ross high school located in Ross township in Butler county. The 1158
high school shall not use the contributions for any political 1159
purpose. 1160

The registrar shall pay the contributions the registrar 1161
receives pursuant to section 4503.964 of the Revised Code to 1162
Chardon hilltopper gridiron club. The club shall use 1163
contributions to fund college and career technical training 1164
scholarships for students. 1165

The registrar shall pay the contributions the registrar 1166
receives pursuant to section 4503.97 of the Revised Code to the 1167
friends of united Hatzalah of Israel, which shall use the money 1168
to support united Hatzalah of Israel, which provides free 1169
emergency medical first response throughout Israel. 1170

The registrar shall pay the contributions the registrar 1171
receives pursuant to section 4503.98 of the Revised Code to the 1172
Westerville parks foundation to support the programs and 1173
activities of the foundation and its mission of pursuing the 1174
city of Westerville's vision of becoming "A City Within A Park." 1175

(C) All investment earnings of the license plate 1176
contribution fund shall be credited to the fund. Not later than 1177
the first day of May of every year, the registrar shall 1178

distribute to each entity described in division (B) of this 1179
section the investment income the fund earned the previous 1180
calendar year. The amount of such a distribution paid to an 1181
entity shall be proportionate to the amount of money the entity 1182
received from the fund during the previous calendar year. 1183

Sec. 4503.542. (A) The owner or lessee of any passenger 1184
car, noncommercial motor vehicle, recreational vehicle, or other 1185
vehicle of a class approved by the registrar of motor vehicles 1186
may apply to the registrar for the registration of the vehicle 1187
and issuance of "Ohio Craft Brewers" license plates. The 1188
application may be combined with a request for a special 1189
reserved license plate under section 4503.40 or 4503.42 of the 1190
Revised Code. Upon receipt of the completed application and 1191
compliance by the applicant with divisions (B) and (C) of this 1192
section, the registrar shall issue to the applicant the 1193
appropriate vehicle registration and a set of "Ohio Craft 1194
Brewers" license plates and a validation sticker, or a 1195
validation sticker alone when required by section 4503.191 of 1196
the Revised Code. 1197

In addition to the letters and numbers ordinarily 1198
inscribed on the license plates, "Ohio Craft Brewers" license 1199
plates shall display an appropriate logo and words that are 1200
selected by representatives of the Ohio craft brewers 1201
association and approved by the registrar. "Ohio Craft Brewers" 1202
license plates shall display county identification stickers that 1203
identify the county of registration as required under section 1204
4503.19 of the Revised Code. 1205

(B) "Ohio Craft Brewers" license plates and a validation 1206
sticker, or validation sticker alone, shall be issued upon 1207
receipt of an application for registration of a motor vehicle 1208

under this section; payment of the regular license tax as 1209
prescribed under section 4503.04 of the Revised Code, any 1210
applicable motor vehicle license tax levied under Chapter 4504. 1211
of the Revised Code, any applicable additional fee prescribed by 1212
section 4503.40 or 4503.42 of the Revised Code, an additional 1213
administrative fee of ten dollars, and a contribution as 1214
provided in division (C)(1) of this section; and compliance with 1215
all other applicable laws relating to the registration of motor 1216
vehicles. 1217

(C)(1) For each application for registration and 1218
registration renewal notice the registrar receives under this 1219
section, the registrar shall collect a contribution of twenty 1220
dollars. The registrar shall deposit this contribution into the 1221
state treasury to the credit of the license plate contribution 1222
fund created in section 4501.21 of the Revised Code. 1223

(2) The registrar shall deposit the administrative fee of 1224
ten dollars, the purpose of which is to compensate the bureau of 1225
motor vehicles for additional services required in the issuing 1226
of "Ohio Craft Brewers" license plates, into the state treasury 1227
to the credit of the public safety - highway purposes fund 1228
created in section 4501.06 of the Revised Code. 1229
