Section 1. All items in this act are hereby appropriated	5

made in this act, those in the first column are for fiscal year	8
2024 and those in the second column are for fiscal year 2025.	9
The operating appropriations made in this act are in addition to	10

CASH TRANSFER FROM THE CONTROLLING BOARD EMERGENCY19PURPOSES/CONTINGENCIES FUND TO THE OSU EXTENSION FUND20

Notwithstanding section 127.19 of the Revised Code, on the21effective date of this section, or as soon as possible22thereafter, the Director of Budget and Management shall transfer23\$500,000 cash from the Controlling Board Emergency24Purposes/Contingencies Fund (Fund 5KMO) to the OSU Extension25Fund (Fund 5YBO).26

Section 3. Within the limits set forth in this act, the 27 Director of Budget and Management shall establish accounts 28 indicating the source and amount of funds for each appropriation 29 made in this act, and shall determine the manner in which 30 appropriation accounts shall be maintained. Expenditures from 31 operating appropriations contained in this act shall be 32 accounted for as though made in, and are subject to all 33 applicable provisions of, H.B. 33 of the 135th General Assembly. 34
