## BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That section 4905.02 be amended and section	6
4933.29 of the Revised Code be enacted to read as follows:	7
Sec. 4905.02. (A) As used in this chapter, "public	8
utility" includes every corporation, company, copartnership,	9
person, or association, the lessees, trustees, or receivers of	10
the foregoing, defined in section 4905.03 of the Revised Code,	11
including any public utility that operates its utility not for	12
profit, except the following:	13
(1) An electric light company that operates its utility	14
not for profit;	15
(2) A public utility, other than a telephone company, that	16
is owned and operated exclusively by and solely for the	17
utility's customers, including any consumer or group of	18
consumers purchasing, delivering, storing, or transporting, or	19

seeking to purchase, deliver, store, or transport, natural gas	20	
exclusively by and solely for the consumer's or consumers' own

(3) A public utility that is owned or operated by any	23	
municipal corporation;	24

(6)(a) A person, business, or other entity that provides,	49	
constructs, or installs for customers utility related service at	50	
a point after service provided by a public utility is delivered	51	
to the public utility's metered points of delivery at the	52

(b) As used in this division, "utility related service"	54	
means the following:	55	
(i) Service or benefit from an advanced energy resource as	56	
defined in section 4928.01 of the Revised Code;	57	
(ii) Electricity, natural gas, or water service;	58	
(iii) Billing service for services described in divisions	59	
(A) (6) (b) (i) and (ii) of this section;	60	
(iv) Electric vehicle charging.	61	
(B)(1) "Public utility" includes a for-hire motor carrier	62	
even if the carrier is operated in connection with an entity	63

(2) Division (A) of this section shall not be construed to	65	
relieve a private motor carrier, operated in connection with an	66	
entity described in division (A)(1), (2), (4), or (5) of this	67

(2) "Utility related service" has the same meaning as in	77 78	
section 4905.02 of the Revised Code.		
(B) Except for reasons of safety or reliability, the	79	
public utilities commission shall not adopt any rule that	80	
permits a public utility to set the location of any of its	81	
meters so that the meter's location prevents a person, business,	82	
or other entity from providing, constructing, or installing	83	
utility related service at a point after the public utility	84	
service is delivered to the public utility's metered point of		
delivery at that location.		
(C) Except for reasons of safety or reliability, no public_	87	
utility shall set the location of any of its meters so that the	88	
meter's location prevents a person, business, or other entity	89	
from providing, constructing, or installing utility related	90	
service at a point after the public utility service is delivered	91	
to the public utility's metered point of delivery at that	92	
location.
