BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That section 3513.04 of the Revised Code be	6	
amended to read as follows:	7	
Sec. 3513.04. (A) Candidates for party nominations to	8	
state, district, county, and municipal offices or positions, for	9	
which party nominations are provided by law, and for election as		
members of party controlling committees shall have their names	11	
printed on the official primary ballot by filing a declaration		
of candidacy and paying the fees specified for the office under	13	
divisions (A) and (B) of section 3513.10 of the Revised Code,	14	
except that the joint candidates for party nomination to the	15	
offices of governor and lieutenant governor shall, for the two	16	
of them, file one declaration of candidacy. The joint candidates	17	
also shall pay the fees specified for the joint candidates under		
divisions (A) and (B) of section 3513.10 of the Revised Code.	19

(B) The secretary of state shall not accept for filing the 20 declaration of candidacy of a candidate for party nomination to 21 the office of governor unless the declaration of candidacy also 22 shows a joint candidate for the same party's nomination to the 23 office of lieutenant governor, shall not accept for filing the 24 declaration of candidacy of a candidate for party nomination to 2.5 the office of lieutenant governor unless the declaration of 26 candidacy also shows a joint candidate for the same party's 27 nomination to the office of governor, and shall not accept for 28 filing a declaration of candidacy that shows a candidate for 29 party nomination to the office of governor or lieutenant 30 governor who, for the same election, has already filed a 31 declaration of candidacy or a declaration of intent to be a 32 write-in candidate, or has become a candidate by the filling of 33 a vacancy under section 3513.30 of the Revised Code for any 34 other state office or any federal or county office. 35

No-(C)(1) Except as otherwise provided in division (C)(2) 36 of this section, no person who seeks party nomination for an 37 office or position at a primary election by declaration of 38 candidacy or by declaration of intent to be a write-in candidate 39 and no person who is a first choice for president of candidates 40 seeking election as delegates and alternates to the national 41 conventions of the different major political parties who are 42 chosen by direct vote of the electors as provided in this 43 chapter shall be permitted to become a candidate by nominating 44 petition, including a nominating petition filed under section 45 3517.012 of the Revised Code, by declaration of intent to be a 46 write-in candidate, or by filling a vacancy under section 47 3513.31 of the Revised Code at the following general election 48 for any office other than the office of member of the state 49 board of education, office of member of a city, local, or 50

(2) Division (C)(1) of this section does not prohibit a	54	
person described in that division from becoming a candidate at	55	
the following general election for an office that is not a state
