"Sec. 4123.651. (A) The employer of a claimant who is injured or disabled in the course of his the claimant's employment may require, without the approval of the administrator or the industrial commission, that the claimant be examined by a physician of the employer's choice one time upon any issue asserted by the employee or a physician of the employee's choice or which is to be considered by the commission. Any further requests for medical examinations shall be made to the commission which shall consider and rule on the request. The employer shall pay the cost of any examinations initiated by the employer.

(B) The bureau of workers' compensation shall prepare or adopt a form for the release of medical information, records, and reports relative to the issues necessary for the administration of a claim under this chapter. The claimant promptly shall provide a current signed release form, or an equivalent form such as the standard form under section 3798.10 of the Revised Code, for the release of the information, records, and reports when requested by the employer. The employer promptly shall provide copies of all medical information, records, and reports to the bureau and to the claimant or his the claimant's representative upon request.

Medical information, records, and reports shall be related causally or historically to physical, psychological, or psychiatric injuries relevant to the claimant's workers' compensation claim.

- (C) If, without good cause, an employee refuses to submit to any examination scheduled under this section or refuses to release or execute a release for any medical information, record, or report that is required to be released under this section and involves an issue pertinent to the condition alleged in the claim, his the employee's right to have his the employee's claim for compensation or benefits considered, if his the employee's claim is pending before the administrator, commission, or a district or staff hearing officer, or to receive any payment for compensation or benefits previously granted, is suspended during the period of refusal.
- (D) No bureau or commission employee shall alter any medical report obtained from a health care provider the bureau or commission has selected or cause or request the health care provider to alter or change a report. The bureau and commission shall make any request for clarification of a health care provider's report in writing and shall provide a copy of the request to the affected parties and their representatives at the time of making the request."

In memory of Stanley J. Aronoff.

WHEREAS, The members of the House of Representatives of the

135th General Assembly of Ohio pay tribute to the memory of Stanley J. Aronoff, who served as a distinguished member of the Ohio House of Representatives and the Ohio Senate; and

WHEREAS, Stan Aronoff will be remembered fondly by all those who knew and loved him, and his absence will leave an irreparable void in our society. Respected for his tenure with the Ohio General Assembly, he was an advocate for the growth and progress of the State of Ohio and its people, and during his time as a legislator, he was an ardent champion for Republican interests as well as the arts. Indeed, he has been credited with establishing the Ohio Arts Council and for supporting the restoration of the Ohio Statehouse, and he has been celebrated for his noteworthy commitment by the naming of the Aronoff Center for the Arts in Cincinnati, the Aronoff Center for Design and Art at the University of Cincinnati, and the Stanley J. Aronoff Laboratory of Biological Sciences at The Ohio State University in his honor; and

WHEREAS, A graduate of Harvard Law School, Stan Aronoff was elected to the Ohio House of Representatives in 1960, where he served three terms and garnered enduring respect from his peers as well as his constituents. In 1967, he was elected to the Ohio Senate, where he spent many of his additional thirty years as a legislator in the positions of president pro tempore and president. His passion for community service was always evident in his own approach to public life, and he strove to be "remembered for more than the bricks and mortar [but] as a person who cares about people." He furthered his contributions to Greater Cincinnati as a lawyer, lobbyist, and consultant, working with Aronoff, Rosen, and Hunt, LPA, Aronoff & Associates, and State Street Consultants, and he dedicated his time to such organizations as the Cincinnati Association for the Arts, the Cincinnati Contemporary Arts Center, the Cincinnati Playhouse in the Park, and the Classical Music Hall of Fame. He was admired by his fellow citizens. friends, and family alike for his positive philosophy of life, and he has left a stalwart legacy to our state that will surely live on; and

WHEREAS, Without question, Stan Aronoff made the world much fuller, and he was especially devoted to the individuals who had a treasured relationship with him, including his wife, Janet, his children, Tracy, the late Jay, and the late Leslie, his grandchildren and great-grandchildren, and his siblings and extended relatives. All those who cherished him can find strength in and solace in the happy moments shared with this great man. Most assuredly, the State of Ohio has benefited exponentially from his life's work, and he will be remembered for his visionary example of citizenship; therefore be it
