INTRODUCTION AND FIRST CONSIDERATION OF BILLS

The following bills were introduced and considered for the first time:

S. B. No. 62 - Senators Reineke, Brenner.

To enact section 5.2316 of the Revised Code to designate October 4 as "Rutherford B. Hayes Day."

S. B. No. 63 - Senator Lang.

Cosponsors: Senators Cirino, Hackett, Huffman, S., Romanchuk, Schaffer, Schuring, Wilson, Rulli, Reynolds, Reineke.

To enact section 2307.931 of the Revised Code to require a plaintiff in a tort action alleging an asbestos claim to file specified disclosures.

S. B. No. 64 - Senators DeMora, Wilson.

Cosponsors: Senators Antonio, Craig, Smith, Brenner, Blessing, Lang, Hicks-Hudson, Schaffer, Hoagland.

To amend section 5919.34 of the Revised Code to expand the Ohio National Guard Scholarship Program.

S. B. No. 65 - Senator Ingram.

Cosponsors: Senators Lang, Craig, Smith, Antonio, DeMora, Hicks-Hudson, Sykes, Reynolds.

To enact section 5.295 of the Revised Code to designate May 13 as "Judge Nathaniel R. Jones Day."

S. B. No. 66 - Senator Ingram.

Cosponsors: Senators DeMora, Smith, Cirino, Hicks-Hudson, Craig, Sykes, Antonio.

To amend sections 3314.03, 3326.11, and 3328.24 and to enact section 3319.324 of the Revised Code to require public and private schools to transmit a transferred student's records within five school days.

S. B. No. 67 - Senators Cirino, O'Brien.

To amend section 3737.83 and to enact section 3781.062 of the Revised Code relating to the State Fire Code and Building Code and to amend the

version of section 3737.83 of the Revised Code that is scheduled to take effect December 29, 2023, to continue the provisions of this act on and after that effective date.

S. B. No. 68 - Senator Hackett.

Cosponsor: Senator Cirino.

To amend sections 9.45, 2925.01, 4710.01, 4710.02, 4710.03, 4710.04, 4712.01, and 4712.99; to amend, for the purpose of adopting new section numbers as indicated in parentheses, sections 4710.01 (4712.50), 4710.02 (4712.51), 4710.03 (4712.52), and 4710.04 (4712.53); to enact sections 4712.502, 4712.54, and 4712.55; and to repeal section 4710.99 of the Revised Code regarding debt adjusting.
