INTRODUCTION AND FIRST CONSIDERATION OF BILLS

The following bills were introduced and considered for the first time:

S. B. No. 129 - Senator Cirino.

To amend sections 4725.01, 4725.011, 4725.02, 4725.09, 4725.11, 4725.12, 4725.121, 4725.13, 4725.15, 4725.16, 4725.18, 4725.19, 4725.20, 4725.21, 4725.23, 4725.231, 4725.24, 4725.25, 4725.26, 4725.27, 4725.31, 4725.34, 4725.35, 4725.501, 4725.531, and 4725.59; to enact section 4725.012; and to repeal section 4725.131 of the Revised Code to revise the law governing the practice of optometry and to amend the versions of sections 4725.13, 4725.18, and 4725.26 of the Revised Code that are scheduled to take effect on December 29, 2023, to continue the changes on and after that date.

S. B. No. 130 - Senator Wilson.

To amend sections 111.16, 147.01, 147.011, 147.03, 147.14, 147.371, 147.53, 147.591, and 1706.712 and to enact sections 147.49 and 147.50 of the Revised Code to amend the law regarding notaries public, to make changes to the Ohio Revised Limited Liability Company Act, to make changes to fees charged by the Ohio Secretary of State, and to amend the version of section 147.01 of the Revised Code that is scheduled to take effect on December 29, 2023, to continue the change on and after that date.

S. B. No. 131 - Senators Craig, Wilson.

To amend section 5.2281 of the Revised Code to change the designation for "Ohio Deaf History Month" to the Month of April.
